Participant's Declaration

1. I herewith grant Gruner + Jahr AG & Co KG, Publishing Group Exclusive&Living, Am Baumwall 11, 20459 Hamburg ("the Publisher"), the right to use the plans and photos I have submitted ("the Material") at any time and at any place in connection with the HÄUSER AWARD 2010, for the coverage of the HÄUSER AWARD 2010 in the print magazine HÄUSER and on the related websites, in connection with exhibitions on the HÄUSER AWARD 2010, for all print editions of the book covering the HÄUSER AWARD 2010 and for the promotion of such book by Callwey Verlag in any media. In particular, the Publisher shall, in respect of the Material, have the right to process and alter the Material (*Bearbeitungsrecht*), in each case preserving the moral rights of the licensor, to reproduce and disseminate the Material (*Vervielfältigungs- und Verbreitungsrecht*), and to make the Material publicly available (*Recht der öffentlichen Zugänglichmachung*). This shall include the right to record, to digitalize and to archive the Material. The Publisher shall not be obliged to publish and / or present the Material. The architect and / or photographer will be named in any publication of the Material.
2. The Publisher is entitled to transfer the rights granted under Section 1 to any third party that is entrusted with any of the projects or events mentioned in Section 1, including, but not limited to, the Callwey Verlag, Munich, in connection with the book covering the HÄUSER AWARD and the operator of the websites of HÄUSER magazine, the Exclusive&Living digital GmbH.
3. The foregoing rights shall be granted free of charge. Callwey Verlag shall forward three (3) voucher copies to the participant which he may use himself and / or forward to the photographer.
4. I herewith confirm that I am either holder of the above-granted rights to the Material or, to the extent that they are third party rights, that I am entitled to grant such rights as described in Section 1 to Section 3. In the latter case I shall inform the Publisher to which extent the third party has agreed to the grant of rights hereunder. The Publisher reserves the right to exclude any Material / participant from the HÄUSER Award if the transfer of rights as required under Section 1 to Section 3 is non-existent or incomplete.
5. The Publisher is entitled to photograph the interior and exterior of the projects I have submitted up until 31.12.2009 and to use such photos in the context and scope as laid out in Section 1 to Section 3. I give my assurance that the owners and occupants of the project agree to the stated usage of the photos. If requested by the Publisher, I will provide the relevant declaration of consent from the persons stated.
6. I give my assurance that the projects I have submitted have not been published in a general-interest magazine before and are not deemed to be published in a general-interest magazine. Furthermore, should I win an Award, I agree that the award-winning building(s) shall not be published in any other general-interest magazine prior to the announcement and publication of the competition results (scheduled for HÄUSER 2/2010).
7. I am obliged to hold harmless the Publisher, Callwey Verlag, Exclusive&Living digital GmbH and any other third party against all third-party claims raised in connection with the use of the rights granted above, provided, however, that such use is in compliance with this declaration.
8. The award jury's decision is final. The laws of the Federal Republic of Germany apply. Should the participant be located outside Germany, any legal case arising from this agreement shall be heard in Hamburg.
9. I accept these conditions of entry as binding.
